#### **Financial Report:**

#### Overview:

The attached financial report for the association was prepared for the financial year June 2015 to June 2016.

This is the first financial report for the association. There was a surplus of \$695 for the year. Whilst that surplus might seem to be minimal it should be viewed in the context of the following factors.

- (a) The association did not commence operations until November 2015.
- (b) There have been limited fundraising events conducted up until June 2016
- (c) The majority of the efforts of the association during the reporting period have been directed towards implementing corporate governance practices and obtaining regulatory approvals
- (d) Significant time in establishing reporting and governance practices with Tandaza Trust Kenya.

There has not been any matter or circumstance occurring subsequent to the end of the financial year that has significantly affected, or may significantly affect, the operations of the Association, the results of those operations, or the state of affairs of the association in future financial years.
